

## **GUIDELINES & RULES FOR 2008**

**To provide an enjoyable and safe PANIC IN THE PARK experience for all patrons, the following Rules of the PANIC IN THE PARK Haunted Attraction are in effect and apply to all patrons (without exception).**

1. **NO SMOKING OR OPEN FLAMES OF ANY KIND, NO EXCEPTION.**  
Anyone caught smoking or with an open flame (lighter, matches, etc.) in the attraction will be immediately ejected from the show.
2. **DO NOT TOUCH ANYTHING, INCLUDING PROPS AND/ OR ACTORS.**  
The PANIC IN THE PARK haunted attraction has a Strict No Touching Policy for the Patrons. The Actors may touch you on occasion. Anyone caught touching props or the actors will risk denied entry or pre-mature removal from the attractions.
3. **NO ALCOHOL, FIREARMS, AND/ OR WEAPONS OF ANY TYPE ARE ALLOWED...**  
they shall not be consumed or carried on the premise (or in parking lot) of PANIC IN THE PARK. Likewise, PANIC IN THE PARK reserves the right to deny entry to and/or pre-maturely eject any individual(s) from the attraction who appear to be and/or display intoxicated behavior that would affect the safety and/or enjoyment of theirs and/or others PANIC IN THE PARK experience.
4. **BE SCARED BUT, BE SAFE.**  
The PANIC IN THE PARK HAUNTED HOUSE prides itself on providing an entertaining thrill and chill fest while maintaining a high standard of patron and staff safety. Any individual(s) who get caught running, horsing around, fighting and/or behaving in an unsafe manner may be warned only once, then risk denied entry or pre-mature removal from the attractions of the PANIC IN THE PARK HAUNTED HOUSE.
5. The PANIC IN THE PARK Haunted attraction and/or any of the PANIC IN THE PARK sponsors/supporters are not responsible for any lost, stolen, and/or damaged possessions of patrons while on the premise of PANIC IN THE PARK. In addition, PANIC IN THE PARK makes all possible reasonable efforts to maintain a safe and enjoyable experience for its patrons. However, the nature of this event may produce certain neglectful behavior in a very small percentage of its attending patrons. For those few, the above mentioned entities are NOT liable for personal injury due to neglectful behavior of patrons such as running (either within or outside the attraction), horseplay, and/or any other forms of unsafe behavior on the part of the patrons that could result in injury. In short.....ENTER AT YOUR OWN RISK.
6. These rules are for each patron's enjoyment and safety while within the attraction. It is the responsibility of the patrons to read and follow these rules.

7. For those few who either cannot make it through the attraction, leave early, or feel they have reason to ask for a refund after the fact, sorry NO REFUNDS. ALL SALES ARE FINAL.
8. All references, resemblances, and statements to persons alive and/or dead are strictly coincidental and are solely used for the overall effect of the attractions at PANIC IN THE PARK. PANIC IN THE PARK and/or any of its affiliates are NOT liable for any perceived offenses of this nature encountered within the attraction and/or premise of the PANIC IN THE PARK attraction.
9. Other than staff, no one is allowed to use flashlights, laser lights, and/or any other forms of illumination, including cell phones, within the attraction. Please NO CAMERAS. If you are caught you may be warned only once, then risk denied entry or pre-mature removal from the attraction.
10. We want you to come back and enjoy PANIC IN THE PARK year after year. So, please drive safely both to and from PANIC IN THE PARK.

\*Please note that we do use special effects, non-toxic smoke, special lighting, etc. and this attraction is not recommended for anyone with concerning medical conditions, heart problems, pregnant women, etc.
